Licenses: Each individual food vendor **must obtain** a *Colorado State Retail Food Establishment License* not later than 2 weeks PRIOR to the event (unless they are approved nonprofit organization). A licensed retail food establishment **should have** a valid Tri-County License for a Temporary Event (\$154). Colorado State Sale Tax License indicating *Douglas County* should be obtained. The Sale Tax is 5.5% Individual Liability Insurance required as well.

- I am a Licensed Retail Food Establishment with a valid Tri-County License for my permanent location
- I do / will have Colorado State Retail Food Establishment License for Temporary Events valid through 08/28/2010.
- I do / will have Colorado State Sale Tax License valid for Temporary Events in Douglas County through 08/28/2010.
- I do / will have Liability Insurance for at least 1,000,000 coverage for Colorado European Festival on 08/28/2010.
- I do have and I bring my own booth, including a tent, tables, chairs and all other equipment I may need at the Festival.
- I understand and agree that I will NOT receive a refund in the case of any interruptions or even the complete cancellation of the 3rd Annual Colorado European Festival at Highlands Ranch due to weather conditions or any other force majeure events that are clearly outside of CEF control.
